Tim also announced to the meeting attendees that the Board of Directors have bestowed the honour of Life Membership of the SHA upon Mary Anne Veroba of Lampman. Mary Anne served twenty years on the SHA Board of Directors including the last seven as Chairperson.

Mary Anne Veroba thanked the Board of Directors and membership for the honour and expressed how pleased she was to be a member of the SHA.

Chairpersons Report

Chairperson Hubic referred the delegates to his written report circulated within the AGM document and touched on the following items:

<u>COVID</u>

- The last fifteen months have been a real challenge. Tim thanked the staff for their efforts during a trying year. The year truly became a "COVID" response one in terms of continually trying to forecast and respond to an ever-changing landscape that no one could control.

Governance Review

- The Board undertook a significant effort into a review of Governance of the Association which Tim will comment on prior to the presentation of the Bylaw Amendment Proposals.

Equity, Diversity & Inclusion

- The Board has undertaken a project to discover where the Association stands in the areas of Equity, Diversity, and Inclusion. The results will assist the Association in creating strategies/initiatives to address the topics.

Hockey Canada

- Tim acknowledged the attendance of Scott Furman from the Hockey Canada Member Engagement Department. Tim expressed his appreciation for the efforts of Hockey Canada staff in the area of Strategic Planning via seeking feedback from the Members.

Sask Hockey Hall of Fame

- The governance of the Saskatchewan Hockey Hall of Fame now falls under the control of the SHA Board of Directors.

MHA Matching Grant Program

- Tim acknowledged the Matching Grant Program created by the SHA Board of Directors and being executed by the staff.

Governance Task Team

 A Task Team was created and consisted of both Board and Non-Board Members representing large, medium-sized and small communities. An outside consultant, Dwight Lawrence, was used to educate the Board of Directors on Policy Governance for Non-Profit Associations and be served as a guide to keep the Task Team on track. The work of the Team resulted in the Notices of Motion to amend the Bylaws that were distributed.

Officials

- Tim advised the attendees that the officiating group within the SHA previously was structured and operated as a "Division" of the SHA. A governance review of the officiating structure took place and a new structure was created with an Officiating Leadership Group being established to lead the Association in the officiating area with an Officer serving as the Chair of the leadership group. Tim thanked Trevor Norum for his leadership and efforts in this area.

Collective Hope

- Tim expressed hope that we all can return to playing the game in a safe and fun environment. Lessons learned over the past year will not be forgotten. The ability to communicate virtually with the membership will be a positive focus in the future.

Tim thanked all MHAs and Volunteers for their commitment and efforts during the past year.

Auditors Report

Chairperson Hubic asked General Manager Kelly McClintock to speak on the audited statement and accompanying Executive Summary contained within the AGM document and which had been circulated to the membership fifteen days prior to the AGM.

The Association experienced a surplus of \$929,679 on operations this past season. Kelly highlighted the following items from his Executive Summary which contributed to the surplus.

- Canadian Wage Subsidy Program of close to \$300,000.
- Return on SHA Investments of close to \$200,000
- No Sask First Programming
- Less Development Programming expenses
- Rebates provided to MHAs, Senior, Junior teams
- Less Insurance paid to Hockey Canada in the Senior, Junior team areas
- **MOTION**: Corntey Lacelle/Joe Larre to accept the 2020/21 audited statement as presented.

Bylaw Amendments

Chairperson Hubic expanded on his talk of the Governance Task Team of the SHA Board of Directors work and the eight Notices of Motion that resulted that the SHA Board of Directors have endorsed.

The proposed Notices of Motion do not impact the operations of the Association but transform the Board to one that focuses on strategic planning and policy development/implementation.

The SHA staff will use virtual calls monthly from September to May to keep in touch with the members form a Operational perspective.

Virtual calls were previously held for the Membership to explain the eight proposed Notices of Motion to explain the rationale behind them.

All Bylaw changes require 75% of those in attendance support.

MOTION #1

Bylaw New - Definitions

Proposed Wording

The following terms have these meanings in these Bylaws.

Act

Saskatchewan Non-Profit Corporations Act, 1995 (*Statutes of Saskatchewan*)

Annual Meeting (AGM)

The General Meeting of the Members as provided for in Bylaw 2.

Auditor

A Public Accountant appointed by the Members by Ordinary Resolution at the Annual General Meeting to audit the books, accounts and records of the Society for a report to the Members at the next Annual General Meeting.

Association

A group of volunteers, whether incorporated as a Non-Profit Corporation or not, organized to administer the operation of hockey within the Bylaws and Regulations of the SHA. The group will be administering hockey within a center or geographic subdivision.

Board

The Board of Directors of the Saskatchewan Hockey Association.

Bylaws

The bylaws of the Saskatchewan Hockey Association as altered from time to time.

Categories

AAA, AA, A, B, C, D in each division.

Chair of the Board

An individual elected to Chair the Saskatchewan Hockey Association Board of Directors.

Director

An individual elected to serve on the Board pursuant to these Bylaws.

Divisions

Means the classes of hockey being operated within the SHA. These are as follows: Senior, Junior, U18, U15, U13, U11, U9 and U7.

Financial Statements

The financial statements of the Saskatchewan Hockey Association prepared according to generally accepted accounting principles established by the Canadian Institute of Chartered Accounts from time to time, consistently applied.

Fiscal Year

Shall have that meaning as defined in Bylaw 5.

General Meeting

Any general meeting of the Saskatchewan Hockey Association's Members.

Hockey Team

Will have the meaning given to it in the Regulations.

In Writing

"In writing" or "written" include printing, typewriting, or any electronic means of communication by which words are capable of being visibly

reproduced at a distant point of reception, including but not limited to email, telecopier (fax), telex or telegraph.

League

A combination of three or more teams registered with the Saskatchewan Hockey Association or with another Hockey Canada Branch competing among themselves based on a regular schedule of games established by an elected or appointed group of individuals registered with this Association.

Member

Shall mean a member as described in Bylaw 1.

Minor Hockey Association

Means as an association, registered as a body corporate in the Province of Saskatchewan which has adopted Bylaws, and regulations that are consistent with the Bylaws and Regulations of Saskatchewan Hockey Association and are approved by the Board and operates a program in Minor Hockey with one or more Hockey Teams in the following Divisions: U7, U9, U11, U13, U15, & U18.

Notice

Whenever a period of notice is required under these Bylaws, the day on which notice is given shall not be counted as part of the notice period, but the day appointed by the notice for the event to which the notice relates shall be counted a part of the notice period.

Officials Development Leadership Team

An entity representing all hockey officials currently registered with the Saskatchewan Hockey Association.

Officers

An Officer of the Saskatchewan Hockey Association as defined in Bylaw 4.

Ordinary Resolution

A resolution passed by a majority of the votes cast on that resolution.

Playing Rules

Rules that govern the game of hockey in Canada, as set out in the Official Playing Rules Book of Hockey Canada and any additional rules approved by the Society, as amended from time to time.

Regular Membership

Shall mean a regular member as described in Bylaw 1.

Regulations

The regulations of Saskatchewan Hockey Association as made and amended from time to time.

Special Meeting

A meeting of members as referred to in Bylaw 2.

Bylaw 2.01.01 Membership

Proposed Wording

Subject to the condition's precedent set out herein and compliance with these Bylaws and the Rules and Regulations of the association, Membership in the Saskatchewan Hockey Association is open to the following:

- a) Any local Minor Hockey Association whose primary place of operations is Saskatchewan provided that the Saskatchewan Hockey Association will only recognize one Minor Hockey Association for each city, town or hamlet.
- All Officiating Development Leadership Team Members who represent all Hockey Officials currently registered with the Saskatchewan Hockey Association.
- c) The following registered Leagues: Junior A, Junior B, Junior C & Senior.
- d) Life Members are considered the members of the SHA.
- **MOTION**: Edward Watson/Len Thomas

MOTION #3

Bylaw 2.02.04 Voting

Proposed Wording

- i. The following shall be entitled to one (1) vote at all Annual Meetings and Special Meetings:
 - a) All members of the SHA Board of Directors. The Chair of the Board shall refrain from voting unless, in the event of a tie, he/she shall cast the deciding vote.
 - b) Officiating Development Leadership Team Members to a maximum of five (5).
 - c) Each member (refer to Bylaw 2.01.01) in good standing (refer to Bylaw 2.01.07) is entitled to cast one (1) vote on any matter on which Members are entitled to vote.
 - d) Each member delegate shall present a credential form of their appointment signed by the President of the Minor Hockey Association or Junior/Senior represented upon registering for an Annual Meeting or Special Meeting. The Member delegate assigned to be the voting delegate for the Member must be designated on the credential form.

Bylaw 2.04.03 Structure of the Board

Proposed Wording

The Board of Directors of the Saskatchewan Hockey Association shall consist of 9 members.

Members of the Board of Directors MUST represent a cross-section of all membership to fulfill the roles to represent the membership on the Policy Governance Board of the Association.

Board approved skills/competency/experience matrix to be created & utilized for Board assessment and candidate recruitment.

Directors of the Board are elected by the membership to three-year terms.

Directors of the Board elect the Board Chair to a three-year term.

Vice Chairperson and Secretary Board positions are appointed annually by the Board of Directors.

Standing Committees:

- 1) Finance/Audit
- 2) Governance/Nominating Committee

Annual General Meeting June 21, 2022

Chairperson's Report: Timothy Hubic

Welcome to the 110th Annual General Meeting of Hockey Saskatchewan.

Wow-what a crazy year (actually, two years). In June of 2021, we had just endured an unwelcomed end of our on-ice activities and were welcoming the off-season to prepare for a fresh start to the 2021-2022 season. The fall of 2021 was unique & difficult. Despite best efforts, planning was a challenge due to the ever-changing restrictions & requirements placed upon our hockey environment by the government and health authorities.

Our staff, led by Kelly McClintock's undaunting commitment, worked tirelessly to get games happening last fall. With the Board and staff working together, we were able to navigate through the effects of the pandemic and conduct a 'close to normal' hockey season for our membership.

After changing the name of our Association in August, Hockey Saskatchewan was launched along with a new website and mobile app to better serve our members. We did enjoy a cautious start to the season that was once again impacted by COVID.

The Board has gone through a maturing process that resulted in Board members being able to focus on the job at hand which was having hockey played in our province. I believe I speak for the entire Board and the senior leadership of Hockey Saskatchewan in saying we are much more interested in administering the game of hockey and not public health issues such as vaccinations & COVID testing requirements.

In reflection, the best part of our team's effort was the experience and knowledge we all gained in creating a solution, then working with our membership to pivot and create a better solution.

With the government and public health restrictions going to the wayside on February 28th, the Board (and staff) were finally able to apply our focus to administering hockey in our province.

This past season, a number of Board projects were resurfaced and completed. This included significant policy updates with Hockey Canada Accredited Schools, Non-Sanctioned Winter Hockey, and many others. The culmination of the efforts by many Board members resulted in finally having a revised Policy Manual as well as a Procedure Manual that gained Board approval this spring.

A matching grant program was established and executed with success. The Association was able to return



close to \$150K to our membership with support for capital projects. Near 80% of our Minor Hockey

Associations utilized the matching grant to improve their community rinks with the small area boards and other improvements to their facilities.

Hockey Saskatchewan will continue to create opportunities and invest resources (including money) to enhance our Minor Hockey Associations for the benefit of the entire membership. A significant component of this investment was initiated near the start of the 2022 year. The Board created a Strategic Planning Task Team guided by a professional consultant. The effort of this task team with the support of the entire Board will not go unnoticed – and resulted in a very useful Strategic Plan that will guide the Association for the coming years.

The pandemic has forced our Association to operate differently and by being adaptable, learning, and maintaining a growth-orientated perspective, we are all stronger and better. We have learned a great many things about how our Association performs and what matters, as well as, in some cases what doesn't matter. This learning will not stop.

Hockey Canada

As one of the 13 Branches that are members of Hockey Canada, our Branch had a high level of engagement in a number of key initiatives. Many of these areas were focused on specific Hockey Canada Policies and related processes.

Hockey Canada and Hockey Saskatchewan share a focus on the areas of Equity, Diversification and Inclusivity – from headlines to social media to the boardroom - a great deal of education and communication focused on these key areas including Maltreatment. Another focus point has been the Female game and growing participation as well as leadership within female hockey.

Relationships are key in developing a greater understanding of our national governing body and the role they play within our Branch. We are extremely fortunate in having long-standing leaders within our Association. Kelly's expertise and experience is respected by all Branches from coast to coast and by Hockey Canada itself. It serves our Association well to have Kelly representing our membership to Hockey Canada in most matters around operations as well as governance. Thank you, Kelly and staff.

Hockey Saskatchewan Board of Directors

The Hockey Saskatchewan volunteer Board of Directors collectively dedicated countless hours towards the effort of firstly, having our players return to the ice post-pandemic and focusing on the priorities of improving our Association for all members.

Our Board of Directors continued the pursuit to make our Association better through a diligent, transparent **focus on policy** while planning for the future. The Board is poised to make significant changes in the upcoming year with a strong focus on policy governance and the execution of our revised Strategic Plan. The



Board's effort this past season and the plan ahead will undoubtedly add great value to the membership.

Equity, Diversity & Inclusion

Last fall the Hockey Saskatchewan Board of Directors committed to an Equality, Diversity, and Inclusion (ED&I) Project. The successful execution of this project included a survey open to the public and resulted in a 450-page comprehensive report from our project partner, Praxis Consulting.

The project identified systemic problems that transcend organized ice hockey in Saskatchewan. The findings of this effort coupled with the refreshed Strategic Plan position the Association to make significant gains in improving hockey for all participants.

On behalf of the Board, I would like to thank all the survey respondents and the volunteers that supported this project from the onset. I would also like to extend a sincere thank you to current Board members Edward Watson and Sarah Hodges (and their committee) for leading the work that made this project a great success.

Governance Committee

A focus this past year has been to review our bylaws and a detailed refinement of Policy & Procedures. The Board, Officers, and committees all spent considerable time & effort on learning, discussing, debating, and finally, forming positions to improve the Association and ultimately provide value to the membership.

Strategic Planning Task Team

A priority through the past couple of years has been a review of our Strategic Plan. This past season, a concentrated effort resulted in a revised Strategic Plan that will help guide decisions moving forward. The process was intense and leveraged the Hockey Canada process where feasible. A sincere thank you to all of those involved in this process and a very special thank you to our partner Wendy Plandowski for her leadership & expertise.

Officials

Our hockey officials continue to transition to a new governance model introduced a couple of years ago. The new model has yet to mature to its capabilities. The pandemic was exceptionally hard on the number of on-ice officials within our branch. A concentrated effort to rebound from the negative effect is required and many initiatives are being considered. Making our officials better on and off ice makes our game better.

The Officials Development Committee has a strong structure of senior leaders guiding new processes and supporting the growth of our hockey officials.



Events

In January of 2021, Radville was finally able to host Hockey Day in Saskatchewan and after a few COVID delays & modifications the dedicated group of volunteers produced a great weekend celebration.

Also returning post-COVID is the Ted Knight Saskatchewan Hockey Hall of Fame Induction Dinner, which is being held on Friday, June 24th, at St. Mary's Cultural Centre in Yorkton.

Hockey Volunteers

Off the ice or on, whether you see them or not, there is an extremely dedicated group of parents and volunteers who keep minor hockey in motion and ensure the best experience for the kids who play the game. Hockey Saskatchewan offers a huge thanks to everyone who spends their time enriching the lives of kids through hockey.

The past couple of seasons, more than ever, we recognize the impact that volunteers have in delivering minor hockey and all hockey across the province. These volunteers found new and creative ways to offer some form of hockey in a safe way during COVID-19. It speaks to the love they have for our game and the benefits it provides to our children. Our Association does not exist without volunteers, and we thank you.

HOCKEY SASKATCHEWAN 2021/22 EXECUTIVE SUMMARY

The following is a summary of the 2021/22 Audited Financial Statement.

As we transitioned from a season that was tremendously impacted by COVID to one where, although able to get a full season in, was still impacted by COVID and world events. Some items that impact the Financial Statement are as follows:

- Canadian Wage Subsidy and Rent Subsidy Program
- Poor return on Hockey Saskatchewan Investments
- Altering Sask First Programming to include camps in August for the creation of Provincial teams due to no programming the previous year.
- Altering how Sask First Tournaments are held with no hotel, meal, and transportation costs during the event as players stayed with their parents.
- Several MHA's either didn't register this past season or saw lower registration numbers.
- Several Senior Teams did not register due to the mandatory vaccine requirement of the Provincial Government for anyone over 18 who didn't want to participate in an activity with a mask.
- Approximately 800 less Officials registered this past season along with reduced numbers of people willing to "coach" officials.

Statement of Financial Position page 1

<u>Assets</u>

The Statement of Cash Flows on page 4 details the cash flow from the past fiscal year and shows a decrease of \$676,690 from last season. This is due to moving cash into the Association's Investment account.

Operations saw a surplus of \$315,026.

Amortization is relatively the same as the previous season.

Accounts Receivable is higher than the previous year. Since April 30th there was still money outstanding however most of it has been collected as of this date.

Our inventories are higher this year compared to last year.

Accounts Payable are much higher at the end of April however that has been taken care of as the date of the Annual Meeting.



The Investments, Note 3, page 7 represents the amount of money Hockey Saskatchewan has invested within a Wood Gundy Investment account and the SHA (now Hockey Saskatchewan) Legacy Fund. The Wood Gundy Investments increased by \$1,267,224 due to moving surplus from the past two seasons into Investments.

Property, Plant and Equipment, Note 4, page 8, details the assets of Hockey Saskatchewan which is essentially the accumulated depreciation on the Hockey Saskatchewan-owned office building, office equipment, truck, trailer, etc. The building amount represents the purchase price of the Hockey Saskatchewan Building in the amount of \$252,000, plus the land allocation of \$50,000, (total Hockey Saskatchewan Building purchase price of \$302,000) and it also includes the leasehold improvements over the past twenty-four years such a paving the parking lot; two replacements of the roof over the past twenty-four years; new heating/air conditioning units; new offices; etc. Equipment represents items such as photocopiers, office furniture and computers. The decreased amount in Property, Plant and Equipment is primarily due amortization expenses outweighing any capital purchases/upgrades.

Liabilities and Net Assets

Accounts Payable, like the Accounts Receivable, are stated here are as of April 30th. This number is much lower as of the current date.

Deferred Revenue is lower as last season we had received a Hockey Canada Branch Pillar Support Grant earlier than normal and this totaled \$109,000.

A further detailed report of the Internally Restricted Net Assets is provided on Page 9 in Schedule 7. Please note that Scholarships expensed within the SDM and Hockey Saskatchewan Scholarship Funds are those awarded, not paid out, therefore the difference in the amounts listed in Notes 3 and 5. The money invested in the Sask Sport area (National Sport Trust Fund) provides a guaranteed return of 5%. Please note that money that was previously allocated to the Referee Scholarship and Referee Funds have been combined with the Hockey Saskatchewan Scholarship Fund.

The Unrestricted Net Assets is the Association's cash and investments upon which there are no restrictions.



Statement of Operations Page 2

The Association experienced a surplus in operations in the amount of 315,026. This statement, along with Schedules 1 to 7 (pages 13 - 19) includes the Association's Budget figures for the 2021/22 fiscal year to provide an analysis.

The following discussion will focus on the comparison of the 2021/22 Audited Figures to the 2021/22 Budget.

Discussion of Variance Detail

<u>Revenue</u>

Sask Lotteries Trust Fund Categorical Grants (Schedule 1, Page 13) All on budget.

National Sports Governing Body

Hockey Saskatchewan receives money annually from a Trust Fund that Hockey Canada set up many years ago from money received during the "self-insured" days of the CAHA. Hockey Saskatchewan receives their allocated proportion of the interest earned on the Fund. This amounted to \$30,500 which is approximately \$20,000 to \$25,000 less than normal due to lower investment returns. Hockey Saskatchewan annually receives interest earned on an account created by Hockey Canada entitled a "Branch Support Pillar". Hockey Saskatchewan received approximately \$60,000 from this account this past season which is approximately \$30,000 to \$35,000 less than previous years. The reduction is the result of a commitment by all provinces to use a portion of this money to upgrade the Hockey Canada Registry and the result of less income from investments along with a lower return on investments of the money within the Pillar.

Self-Help (Schedule 2 – page 14)

Overall registrations for Hockey Saskatchewan were down for the 2021/22 season.

The reduction in fees is also impacted by the fact that Hockey Canada did not charge their \$3 per participant rate for the season and they will be implementing that again for the 2022/23 season. Therefore, the per participant rate will be \$48.

There were less Senior teams registered primarily since to play without wearing a face covering/mask as directed by the Provincial Government they had to be fully vaccinated. Many teams decided to take a year off due to that and worried about being shut down again like the previous season.

Adult Rec saw fewer players participating in the CANLAN programs in Regina and Saskatoon. Female Hockey numbers rose which is really encouraging.

Junior did not meet budgeted expectations primarily since Junior B must now wear a full-face mask and therefore pay lower insurance premiums.

Minor Hockey did not meet budgeted expectations due to the \$3 participant fee plus fewer registrations. Most communities in the far north did not register due to COVID once again.

Transfers represent transfer fees for Junior and Senior players from other provinces or overseas in the



case of Senior players returning from Europe.

Other Revenue (Schedule 3 – page 15)

Within Marketing, there was difficulty attempting to attract new sponsorships as there was a hope to obtain one additional large sponsor and the level of clothing sales was not achieved. However, there was an opportunity through Hockey Canada to operate a Province Wide 50/50 through the World Junior event and that initiative created a found Revenue of over \$33,000 for the Association. This will become an annually initiative during the World Junior wherever it is held.

There was no Sask First (Excellence) programming due to not having the players stay in hotels as teams for Sask First Tournament events there were reduced expenses for hotels, meals, and transportation from the hotel to the rink and therefore lower fees were collected.

Officiating Revenue was down simply due to lower registration numbers and not being able to offer the level of coaching to specific leagues that resulted in lower revenue from those leagues to help offset expenses.

Investment revenue was poor as we have all experienced in our private lives and this took place from the end of January on.

The Association took advantage of the Canadian Emergency Wage Subsidy and Canadian Emergency Rent Subsidy Programs that allowed for employees to continue their employment and eliminate any layoffs or terminations. Hockey Saskatchewan leases space in our building to the Saskatchewan High School Athletic Association and Regina High Schools Athletic Association.

Within our budget, an amount of \$200,000 was allocated from the previous years surplus for the MHA Grant Program conducted last year. There was over \$144,000 paid out through the program and ultimately the \$200,000 was not required.

Expenses

Administration

The Administration Schedule 4 is on page 16.

Overall, the Administration budget was under by \$60,677.

Fees to complete our Audit, GST and Income Tax Return decreased by \$3,000.

We were able to be part of a Hockey Canada initiative through the HCR in working with a new credit card company which lowered amount of fees paid by over 50%. There is strength in numbers in obtaining a deal nationally.

We had increased expenses in Legal around some situations that arose last summer.



We had lower than budgeted expenses for Divisional Expenses which is travel to Provincials, League Meetings, Regional and National Competitions, etc.

With a move to conducting almost all clinics virtually there was substantial savings in postage and express for sending materials to clinic instructors throughout the province.

Capacity/Interaction

The Capacity/Interaction Section is Schedule 5, Page 17.

Overall, in this area we experienced savings of \$129,132.

The savings were experience in primarily two areas.

Marketing was reduced strictly due to lower sales of clothing and the cost of the goods sold would be reflected here. In addition, the expenses with Hockey Day in Saskatchewan were lower with a slightly condensed version with no Banquet or SJHL game due to COVID.

There were significant savings in Meetings as the Hockey Saskatchewan Board of Directors and Officiating meetings was primarily held virtually and there were savings with all virtual Hockey Canada Meetings as well.

The Volunteer and Staff Development account included the expenses to complete the ED&I Project that was completed over the past season.

Participation

The Participation Section is Schedule 6, Page 17.

Overall, in this are we experienced savings of \$321,598.

Within Coaching Development, the move from in-class coaching clinics to virtual ones reduced expenses in conducting them.

With concerns around COVID our Coach Mentorship initiative at the U7 level was not as successful and training sessions for mentors were not held.

Within Officiating Development, the move to virtual clinics reduced expenses however there was a reduction in the amount of people "coaching" officials at all levels due to shortage on "coaches" and shortage of officials.

We did not reach projected levels of IP Jamborees due to COVID concerns/close contact guidelines which made groups hesitant to host events.



We had fewer female registrations for Female Festivals/Jamborees however the Futures program was sold out.

Excellence

The Excellence Section is Schedule 7, Page 19.

Overall, in this are we experienced savings of \$254,063.

The number one reason for the savings is that with COVID a decision was made in the hosting of the Sask First Tournaments that all players would stay with their parents. Normally all players are housed within their team in a hotel four to a room; fed at the hotel; and bused to and from the hotel. All these expenses no longer we absorbed and the corresponding reduction in the fees collected also occurred.

Hockey Canada Insurance/Membership/Other

The amount of insurance paid to Hockey Canada was reduced, primarily in the Minor, Junior, and Senior categories due to lower registration.

Hockey Canada also reduced it per participant membership fee of \$3.00 per participant to 0 which reduced the amount paid by Hockey Saskatchewan by over \$50,000.

There was also no need to use surplus funds to pay for the MHA Grant Program.

To the Members of Hockey Saskatchewan

Qualified Opinion

We have audited the financial statements of Hockey Saskatchewan (the Entity) which comprise:

- the statement of financial position as at April 30, 2022
- the statement of operations for the year then ended
- the statement of changes in net assets for the year then ended
- the statement of cash flows for the year then ended
- and notes to the financial statements, including a summary of significant accounting policies

(hereinafter referred to as the "financial statements").

In our opinion, except for the possible effects of the matter described in the "Basis for Qualified Opinion" section of our auditors' report, the accompanying financial statements, present fairly, in all material respects, the financial position of the Entity as at April 30, 2022, and its results of operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Qualified Opinion

In common with many not-for-profit organizations, the Entity derives revenue from registrations, clinics and donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the Entity.

Therefore, we were not able to determine whether any adjustments might be necessary to:

- the current assets reported in the statements of financial position as at April 30, 2021 and April 30, 2022
- the registrations, clinic, and donation revenues and excess of revenues over expenses reported in the statements of operations for the years ended April 30, 2021 and April 30, 2022
- the unrestricted net assets, at the beginning and end of the year, reported in the statements of changes in net assets for the years ended April 30, 2021 and April 30, 2022
- the excess of revenues over expenses reported in the statements of cash flows for the years ended April 30, 2021 and April 30, 2022.

Our opinion on the financial statements for the year ended April 30, 2021 was qualified accordingly because of the possible effects of this limitation in scope.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the "*Auditors*' *Responsibilities for the Audit of the Financial Statements*" section of our auditors' report.

We are independent of the Entity in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada and we have fulfilled our other ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Entity's financial reporting process.

1. Nature of operations:

Hockey Saskatchewan, ("the Entity") is a provincial sports governing body that administers the operations of hockey in Saskatchewan. Its primary objectives are to foster and promote hockey and to promote, supervise and administer all competitions for hockey in Saskatchewan. During the year, the Entity changed its name from Saskatchewan Hockey Association to Hockey Saskatchewan.

2. Significant accounting policies:

These financial statements are prepared in accordance with Canadian accounting standards for not-for-profit organizations ("NPO"). The Entity's significant accounting policies are as follows:

(a) Revenue recognition:

The Entity follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonable assured.

Registration revenue is recognized over the membership period.

(b) Government assistance:

Government assistance refers to governmental actions that provide specific funding to an individual enterprise. Government assistance toward current expenses or revenues are included in the determination of excess of revenue over expenses for the period and is disclosed in note 10.

Notes to Financial Statements (continued)

Year ended April 30, 2022

2. Significant accounting policies (continued):

(c) Financial assets and liabilities:

Financial instruments are recorded at fair value on initial recognition. Equity instruments that are quoted in an active market are subsequently measured at fair value. All other financial instruments are subsequently recorded at cost or amortized cost, unless management has elected to carry the investments at fair value. Management has elected to carry investments at the fair value.

Transaction costs incurred on the acquisition of financial instruments measured subsequently at fair value are expensed as incurred. All other financial instruments are adjusted by transaction costs incurred on acquisition and financing costs, which are amortized using the straight-line method.

Financial assets are assessed for impairment on an annual basis at the end of the fiscal year if there are indicators of impairment. If there is an indicator of impairment, the Entity determines if there is a significant adverse change in the expected amount or timing of future cash flows from the financial asset. If there is a significant adverse change in the expected cash flows, the carrying value of the financial asset is reduced to the highest of the present value of the expected cash flows, the amount that could be realized from selling the financial asset or the amount the Entity expects to realize by exercising its right to any collateral. If events and circumstances reverse in a future period, an impairment loss will be reversed to the extent of the improvement, not exceeding the initial impairment charge.

(d) Inventory:

Inventory is valued at the lower of cost and net realizable value.

(e) Property, plant and equipment:

Property, plant and equipment are stated at cost, less accumulated amortization. Amortization is provided using the following methods and rates:

(f) Income taxes:

Hockey Saskatchewan is continued under *The Non-Profit Corporations Act of Saskatchewan*. Under present legislation, no income taxes are payable on reported income of such organizations.

(g) Use of estimates:

The preparation of the financial statements in conformity with NPO requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenue and expenses during the reporting period. Significant items subject to such estimates and assumptions include the recoverability of accounts receivable and the estimated useful lives of property, plant and equipment. Actual results could differ from these estimates.

7. Internally restricted net assets (continued):

The Entity's Board of Directors internally restricted the following amounts from unrestricted net assets. The amounts are not available for other purposes without the approval of the Board of Directors.

Legacy Fund:

The Entity has established a Legacy Fund which is being administered by Sask Sport Inc. Donations can be made to Sask Sport Inc. for which the donor receives a charitable receipt. The intention of the Legacy Fund is to generate interest to support grass roots development programs. During the year, the Referee Fund was transferred into the Legacy Fund.

Saskatchewan Development Model Scholarship Fund:

The Entity has established a Saskatchewan Development Model Scholarship Fund. The monies will be used to fund up to twenty-four \$1,000 scholarships to eligible members on an annual basis.

Hockey Saskatchewan Scholarship Fund:

The purpose of the fund is to pay scholarships to registered eligible members on an annual basis. The balance may only be reduced by the approval of at least two-thirds of the membership of the Entity at an annual general meeting. During the year, the Referee Scholarship Fund was transferred into the Hockey Saskatchewan Scholarship Fund.

Referee Scholarship Fund:

The amount provides a source of funding for scholarships for eligible referees.

Referee Fund:

This amount provides a source of funding for future Referee programming.

Building Fund:

This amount provides a source of funding for building renovations.

8. Contingencies:

The Entity is contingently liable with respect to a portion of the claims against the Hockey Canada National Insurance Equity Fund in excess of premiums paid to the Fund by the member Entities. Should any loss to the Entity result from the resolution of the claims, it will be accounted for in the year of settlement.

9. Risk management:

Exposure to market risk, credit risk, and liquidity risk arise in the normal course of the Entity's business.

(a) Market risk:

Market risk is the risk of loss that results from fluctuations in equity prices, interest, and exchange rates. The Entity is exposed to market risk from its investing activities. The level of risk to which the Entity is exposed varies depending on market conditions and the composition of the asset-mix.

(i) Price risk:

The Entity manages price risk primarily through diversifying the investments across industry sectors and through investment strategies. As at April 30, 2022 the Entity had an unrealized loss of \$20,262 (2021 – unrealized gain of \$36,931) on its investments.

(ii) Currency risk:

Currency risk arises from the Entity's holdings of foreign currency-denominated investments.

(b) Liquidity risk

Liquidity risk is the risk that the Entity will be unable to fulfill its obligations on a timely basis or at a reasonable cost. The Entity manages its liquidity risk by monitoring its operating requirements. The Entity prepares budget and cash forecasts to ensure it has sufficient funds to fulfill its obligations.

(c) Credit risk

Credit risk refers to the risk that a counterparty may default on its contractual obligations resulting in a financial loss. The Entity is exposed to credit risk with respect to the accounts receivable and investments. The maximum exposure is the carrying amount of these financial assets on the statement of financial position. The Entity assesses, on a continuous basis, accounts receivable and expenses any amounts that are not collectible.

10. Government assistance:

Canada Emergency Wage Subsidy

The Entity has applied for and received financial assistance during the year from the Canadian government under the Canada Emergency Wage Subsidy (CEWS) amounting to \$88,236 (2021 - \$297,122). The CEWS is a government assistance and has been recognized as other revenue in the statement of operations and disclosed in Schedule 3.

Canada Emergency Rent Subsidy

The Entity has applied for and received financial assistance during the year from the Canadian government under the Canada Emergency Rent Subsidy (CERS) amounting to \$3,228 (2021 - \$1,916). The CERS is a government assistance and has been recognized as other revenue in the statement of operations and disclosed in Schedule 3.

Federal Emergency Support for Sport Organizations

The Entity has applied for and received financial assistance during the year from the Federal Government under the Emergency Support Program for Sport Organizations amounting to \$11,190 (2021 - \$337,280). The support is a government assistance and has been recognized as a reduction of expenses incurred during the year to support local hockey organizations in the same amount.
