Acknowledgement

Chairperson Watson acknowledged the contribution of departing members of the Board of Directors, Nicole Korpusik who has spent four years on the Board and stepped in last season to replace a Director who had resigned. He also recognized Tim Hubic who resigned from the Chairperson position following the Annual General Meeting last year after serving fifteen years on the Board of Directors guiding the Association through COVID and a Board transition from twenty-three members to nine.

Meeting Protocol

Chairperson Watson advised the meeting attendees of the following:

- As per **current Bylaw 2.04.01 b) i)** the Hockey Saskatchewan Board of Directors have the right to amend or alter the Regulations or Playing Rules of Hockey Saskatchewan. That was completed in April and a summary of the changes forwarded to Membership in May. Any questions regarding them may be brought up in the Question-and-Answer period, however there is **no voting on those amendments or alterations to the regulations or Playing Rules.**
- We do have 10 **Notice of Motions** to amend the current Bylaws - to be considered at this meeting.
- And just a reminder our **current Bylaw 2.04.02** states that at least 75% of the votes in favor are required to carry any motion to amend our Bylaws.
- **Bylaw 2.04.03 – further states that any amendments or changes to the Bylaws which are carried at the AGM shall take effect immediately.**
- **Before we get to the actual voting** on the notice of motions – just a quick couple of items:
 - The Board of Directors have given great consideration to the Bylaw amendments we are considering tonight and at the April Board meeting – the **Board endorsed all of the amendments *unanimously* and are now presenting them to the membership for approval. As per Bylaw 2.03.04 b): The Chair of the Board shall cast the Board’s eligible votes in one block vote.**

Chairpersons Report

Chairperson Watson referred the delegates to his written report beginning on Page 18 of the AGM Booklet circulated prior to the meeting.

Chairperson Watson touched on the following items from the report.

- Board is dedicated to pursuing education to become better board members and a better functioning Board focussing on better policy and governance principles
- This past year the focus was on decision-making processes, financial literacy and policy creation, as well as identifying areas of risk and who is responsible for those risk areas
- The Board has also adopted a new strategic plan along with updated Mission, Vision and Values statements. We believe that by adhering to these we can not only have a positive impact on the hockey community within Saskatchewan but on individuals involved in the game as well
- I encourage everyone to check out the Sport a Rainbow initiative. The most recent Beyond the Boards event in Ottawa had a focus on the impact of hockey on individuals struggling with their own personal identity and this initiative is a way to indicate that everyone should be welcomed within the game in our province.
- I want to highlight the challenges that are coming at us regarding non-sanctioned hockey. If we are to continue to grow our game, we have to listen to those who are choosing to participate outside of our sanctioned-hockey system and evolve and possibly adapt. As people get to have more and more choice of places to play, we must make sure that we are continuing to provide the best player experience to draw participants into our fold. Listening to understand others perspective and desires is the only way to continue to stay nimble with program delivery and we need your help to stay up to date and ahead of the curve.

Auditors Report

Chairperson Watson asked General Manager Kelly McClintock to speak on the Audited Statement and accompanying Executive Summary contained in the AGM booklet which had been circulated to the delegates prior to the meeting.

The Association experienced a surplus of \$296,100 on operations this past season. Kelly highlighted the following items from his Executive Summary which contributed to his surplus.

There were several items that impacted the 2024-25 Audited Financial Statement in comparison to the 2023-24 fiscal year:

- An increase in Annual Funding from Sask Sport of \$17,900.
- An increase in Membership Assistance Program Funding from Sask Sport of \$9,900.
- An increase in funding from Hockey Canada due to the World Junior event in Ottawa.
- An increase in Player/Team Official and Officials Registration.
- An increase in revenue from Video Reviews.
- Reduction in revenue from the World Junior 50/50 than what was expected.
- Reduction in MHA Evaluation revenue with a corresponding reduction in expenses.
- Significant increase in interest earned on Bank Balance plus investment returns of over \$350,000. Without this return the Association would be in a loss position.
- Absorbing the Green Arm Band initiative expense that was added to budget.
- Conservative budgeting within the Excellence (Sask First) programming and coming \$46,000 under budget.
- Increase in Hockey Canada insurance and assessment fees being paid due to increased registration.

CHAIR REPORT

Welcome to the 113th Annual General Meeting of Hockey Saskatchewan.

Before we begin, I'd like to acknowledge that we have attendees joining us from across the province,

lands covered by Treaties 2, 4, 5, 6, 8, and 10, and the traditional territories of the Cree, Dakota, Dene,

Lakota, Nakota, and Saulteaux peoples, as well as the homeland of the Métis. We gather today in a spirit

of respect and reconciliation, to honor our relationships and shared responsibilities.

Vision, Mission & Strategic Direction

During the 2024–25 season, the Board of Directors revisited Hockey Saskatchewan's Vision, Mission, and

Values. As a result, updated statements were adopted, reaffirming our direction and helping guide our

newly developed three-year Strategic Plan. This plan will serve as our road map into the future.

About Your Board of Directors

- Hockey Saskatchewan is the governing body for organized amateur hockey in the province.
- The Board provides strategic oversight and approves the vision and policy framework for operations.
- Day-to-day operations are delegated to the General Manager.
- The Board operates under a policy governance model.
- In 2022, the Board transitioned from a 23-member representative model to a 9-member policy board, improving agility and accountability.
- The Board's role is future-focused: providing strategic leadership, oversight, insight to the General Manager, and connections to members and stakeholders.

In the past year, the Board identified several governance challenges that may have limited growth and

effectiveness. To address these, a number of motions have been proposed for member consideration.

These proposals are intended as the first step toward a more efficient and diverse Board, and continued

reflection will be key as we evolve into a high-functioning oversight body.

Key Initiatives & Programs

Player Development

This season staff introduced some new initiatives to assist with player development. With the help of our extensive lineup of skills coaches, skills camps focusing on the the defence position were introduced. These were highly successful from an attendance standpoint and the skills gained will start to be realized on the ice as the players further develop.

This season also saw the introduction of the U13 SaskFirst Futures for male participants. Once again this initiative was exempt popular and spots were almost immediately filled. The demand recognized a desire for this program to grow in the coming years

Senior Hockey Revitalization

Senior hockey participation in provincial playoffs this season was great to see. Following the changes to the provincial playoff regulations, we had several teams enter the playoff tournament who had never entered in the past. The Senior D draw probably saw the greatest revitalisation. The games in all the draws were highly competitive and entertaining. At the end of the playoffs teams were asked about further changes to the formats and at this time it was indicated to not make any further changes.

Risk Management & Governance Tools

The Board continued to focus on areas of risk. The area drawing the most focus this year was conflict of interest. While understanding that most of not all volunteers within hockey will have some conflict or perceived conflict, recognizing and declaring those conflicts helps to mitigate the risk and create a transparent decision making process.

Nominating Committee

The Nominating Committee operates at arm's length from the Board and oversees board assessment,

recruitment, and vetting of candidates.

The committee is continuing its work to enhance transparency and effectiveness in the nomination process.

Leading Cultural Change

Addressing Maltreatment

Hockey Saskatchewan continues to work towards a place where play participants are welcome to compete and enjoy the game in a fun, safe environment. This season officials were provided additional guidance on the standards and expectations regarding maltreatment. While there continues to be incidents that occur, having a more standard approach to calls should help recognize those who cross the line.

Board Education & Development

This season, the Board committed to becoming more educated and effective:

- All Directors completed the Governance Essentials e-Learning Course (Sport Law & Canadian

Centre for Ethics in Sport).

- In November, Wendy Plendowski delivered a session focused on Conflict of Interest and Separation of Governance and Operations.
- In January, Brandi Tracksell facilitated a session Focused on clarifying our roles in Governance, Leadership and accountability. Was spent identifying possible risks to the Association then determining where the accountability for monitoring and addressing

those risks falls, either with the Board, Staff or both. At the end of the session there was a greater understanding of those responsible and accountable within the policy/governance model fall

These professional development efforts provide a solid foundation for strong, ethical, and strategic

leadership.

Looking Ahead

Your Hockey Saskatchewan Board of Directors has a clear focus on meeting the highest standards of governance to provide the best outcomes for the Members. As part of this focus, further changes to the involvement of the Board within areas that fall into the operations of the Association are being identified. The goal of the Board is to have a highly competent and functional staff which conducts the business of the Association with appropriate Board oversight. In the coming seasons there may be further changes to the Board responsibilities taking it further into the policy/governance areas and further from the day to day operations of the Association. The Board and Staff have built up a high level of trust that each is operating to the highest standards, and we ask that you trust the Board and Staff to provide the best product possible for you and your members. If you find areas of concern that need to be addressed we all that you reach out to any board member of it relates to policy/governance so that we can attempt to move the Association forward.

GENERAL MANAGER REPORT

The 18th annual Hockey Day in Saskatchewan event was hosted in Avonlea in January 2026 with the event generating over \$230,000 which will be used towards construction of new dressing rooms on the Avonlea Arena. A big thank you to the Host Committee.

The rotation for the host community for Hockey Day in Saskatchewan for the next six years is as follows:

- 2027 - Zone 7
- 2028 - Zone 1
- 2029 – Zone 5
- 2030 – Zone 8
- 2031 – Zone 4
- 2032 – Zone 3

Hockey Saskatchewan has made some slight adjustments to its MHA Matching Grant to increase funding to the larger Associations based upon membership size. The grant which will be moving into its fourth year and is designed to assist MHAs in the hiring of Power Skating Instructors for kids in the U7 to U13 age groups. Hockey Saskatchewan feels that this assistance will assist in the most important skill associated with the game, skating! It is hoped that as a young player's skating ability increases, their confidence in playing the game increases, and the longer they will want to participate in the game from a retention perspective.

Of course, Fun is the most important aspect of any activity and if a child doesn't have Fun they likelihood of participating in any activity, including hockey is unlikely therefore we encourage all MHA's and parents to visit the Where Fun Wins! Portion of the Hockey Saskatchewan website to view all sorts of valuable age group specific information from learning about the Hockey Saskatchewan Values to Safety to Practice Drills!

I would like to thank all the staff of Hockey Saskatchewan for the countless hours they contributed to the development of the game in our province. Their passion is unrivaled, contagious, and without them, my job certainly would be extremely difficult! In many instances, it is I that receives the accolades for achievements that our staff are responsible for so please thank them when you see them.

On behalf of the Hockey Saskatchewan Board of Directors, I am writing to advise the membership of the nomination and election process for the Board of Directors for the 2026 Hockey Saskatchewan Annual General Meeting to be held Tuesday evening, August 4, 2026.

Hockey Saskatchewan's Nomination Committee operates at arm's length from the Board of Directors and is chaired by Mary Anne Veroba, former President/Chair of the Board of Hockey Saskatchewan.

All nominations are forwarded directly to the Nominations Committee who review, interview and background check all nominees. They then recommend the individuals they feel are best suited to serve on the Board of Directors as a slate to be presented to the Membership at the Annual Meeting.

The Membership will be asked to approve the Nominations Committee recommendations during the Annual General Meeting.

There were three positions open for the Board of Directors as of the Annual General Meeting in August. Two of the open positions had to be filled by Females to meet the Hockey Saskatchewan Bylaws gender requirements. Please refer to Bylaw 2.05.03 a) which reads as follows:

"The Board of Directors shall consist of nine (9) Directors of which not more than two-third (2/3) are of the same gender. (6 of 9 is max. for one gender)"

Based upon the nominations received the Nominations Committee are putting forward the following nominees to be approved by the membership for three-year terms on the Board of Directors:

Ryan Hoffman, Regina

As there was only one female nomination received, the Nomination Committee will conduct a search to recommend to the Board of Directors a one-year appointment of second female candidate in order to meet the Bylaw 2.05.03 a).

This will then mean that at the 2027 Annual General Meeting there will be three three-year openings and one two-year opening available on the Board of Directors.

HOCKEY SASKATCHEWAN 2025/26 AUDITED FINANCIAL STATEMENT EXECUTIVE SUMMARY

The following is a summary of the 2025/26 Audited Financial Statement.

This year's Audit is the first to be completed by The Virtus Group for Hockey Saskatchewan so there are some slight changes to the presentation.

There were several items that impacted the 2025/26 Audited Financial Statement in comparison to the 2024/25 fiscal year:

- An increase in Annual Funding from Sask Sport of \$13,900.
- An increase in Membership Assistance Program Funding from Sask Sport of \$18,100.
- An increase in Player/Team Official and Officials Registrations.
- An increase in the Per Participant Fee due to an increase by Hockey Canada which affects both Revenue and Expenses.
- An increase in revenue from Video Reviews.
- Reduction in revenue from the World Junior 50/50 than what was expected.
- Increase in MHA Evaluation revenue with a corresponding increase in expenses.
- Increase in the number of Defensemen PD Cams with a corresponding increase in expenses.
- Addition of a Male U13 Prospects Program.
- Significant increase in interest earned on Bank balance plus investment returns of over \$652,800 plus interest earned on Scholarship and Legacy Funds for a total interest earned of almost \$706,000. Without this return the Association would be in a loss position.
- Increase in Hockey Canada assessment fees being paid due to an increase in those fees.
- Reporting the Scholarships paid as of April 30, 2026, within the Statement of Operations.

Statement of Financial Position page 1

Assets

The Statement of Cash Flows on page 4 details the cash flow from the past fiscal year and shows an increase of \$148,410 from last season. Please note that \$57,768 of the Associations expenses are not cash amortization (depreciation) expenses.



EXECUTIVE SUMMARY

Operations saw a surplus of \$585,098 primarily due to the Investment Portfolio of the Association which is the Market Value of the Investments as of April 30, 2026, compared to April 30, 2025, plus the interest earned over the year.

Accounts Receivable are lower than the previous year as of April 30th, however much of that has been collected as of this date.

Our inventories are higher this year as last season a number of items were written off at year end.

The Investments, Note 3, page 6 represents the amount of money Hockey Saskatchewan has invested within a Wood Gundy Investment account and Hockey Saskatchewan Legacy Fund. Wood Gundy Investments increased by \$769,042 due to moving a portion of surplus from the past season into Investments along with an increased market value of the investments as of April 30, 2026.

Tangible Capital Assets, Note 4, page 6, details the assets of Hockey Saskatchewan which is the accumulated depreciation on the Hockey Saskatchewan-owned office building, office equipment, truck, trailer, etc. The building amount represents the purchase price of the Hockey Saskatchewan Building in the amount of \$252,000, plus the land allocation of \$50,000, (total Hockey Saskatchewan Building purchase price of \$302,000) and it also includes the leasehold improvements over the past twenty-eight years such a paving the parking lot; two replacements of the roof over the past twenty-eight years; new heating/air conditioning units; new offices; etc. Equipment represents items such as photocopiers, office furniture and computers.

Liabilities and Net Assets

Accounts Payable, like the Accounts Receivable, is stated here as of April 30th. This number is much lower at the current date.

A further detailed report on the Internally Restricted Net Assets is provided on Page 7 in Note 5. Please note that Scholarship expenses within the SDM and Hockey Saskatchewan Scholarship Funds are those paid out. The money invested in the Sask Sport area (National Sport Trust Fund) provides a guaranteed return of 5%.

The Unrestricted Surplus in Net Assets is the Association's cash and investments upon which there are no restrictions. They include the cash in the bank, Wood Gundy Investments and the Sask Sport Legacy account.

The Association experienced a surplus in operations in the amount of \$585,098.

Discussion of Variance Detail

Revenue

Sask Lotteries Trust Fund

Categorical Grants (Schedule 1, Page 11)

The Aboriginal Sport Enhancement Grant assists the formation of Men's and Women's teams to participate in the National Aboriginal Hockey Championships.

The Adaptive Sport Enhancement Grant assist Para Hockey Groups with the purchase of sleds and equipment.

Future Best is a Sask Sport assistance program for Nationally Carded Athletes.

There was an increase in the Membership Assistance Program Grant.

The Next Generation Indigenous Grant is another Sask Sport Initiative that is available to high caliber Indigenous players to assist with their development.

There are two grants to Assist the four University Programs in the Province plus student athletes on those programs.

National Sports Governing Body

Hockey Saskatchewan receives money annually from a Trust Fund that Hockey Canada set up approximately thirty years ago from money received during the "self-insured" days of the CAHA.

Hockey Saskatchewan receives their allocated proportion of the interest earned on the Fund.

Hockey Saskatchewan shares a percentage of the profits for events such as the World Juniors when held in Canada and the financial success of the event in Ottawa resulted in Hockey Saskatchewan receiving \$65,000 as an initial payment with an additional amount of over \$50,000 also being received.

Self-Help (Schedule 2 – page 9)

Overall registrations for Hockey Saskatchewan were up for the 2025/26 season.



EXECUTIVE SUMMARY

The sole area of where there was a decrease is the Adult Rec area where the FSIN ceased to host annual their Adult Rec Provincial Championships which were sanctioned by Hockey Sask and therefore we only receive revenue through Hockey Canada for the Canlan programs operating in the province.

Other Revenue (Schedule 3 – page 10)

There was an increase in money received for Video Reviews/Appeals/concessions.

There was a large increase in the number of participants in the Hockey Sask Defensemen PD Camps, which increased revenue and expenses.

Coaching Clinics (Coach 1 and 2/Development 1/Body Checking/Trainer Online Modules) and Coach Mentorship are a matter of the allocation of Sask Sport Membership Assistance Grant money to offset expenses in those areas.

Sask First (Excellence) programming rose due to increased registration numbers in all programs.

Investment revenue was extremely positive with \$705,965 earned, which was close to \$431,000 more than budgeted for. The money earned is a combination of interest earned and the value of the investments increasing.

The World Junior 50/50 initiative was expected to bring in \$80,000 in revenue, however only brought in \$56,446.

Hockey Saskatchewan provided Evaluation services to additional MHA's than in the past which resulted in an Increase in both Revenue and Expenses.

Officiating Revenue was up due to an increase in the Registration numbers.

Sundry was much lower as the number of coaching fines dropped significantly, which is a real positive trend.



Expenses

Administration

The Administration Schedule 4 is on page 10.

Overall, the Administration budget was under by approximately \$2,500.

The Association conducted an RFP for new auditing services, and the results are a lower expense of approximately \$15,000.

Bank and Credit Card expenses as more Associations/Teams are paying by credit card.

Computer Programming and Hosting increased by \$8,500.

Occupancy Cost were lower this past year for the Associations building by \$12,200.

The Association no longer pays Office Allowances or Honorariums to volunteers on the Board of Directors.

Office Supplies and printing was \$5,600 less this past year.

Salaries and benefits were approximately \$42,000 higher due to adding another staff member in the Marketing and Communications area.

Capacity/Interaction

The Capacity/Interaction Section is Schedule 5, Page 11.

Overall, in this area we were approximately \$28,000 under budget.

With the Association website, \$5,000 was spent above budget

In the area of Culture, Member Education and Inclusion we were approximately \$21,000 under budget. Within the area of meetings, there was an over-expenditure of \$6,000.

Within the Marketing area we were approximately \$16,000 under our projected budget spend.

Participation

The Participation Section is Schedule 6, Page 11.

Overall, in this area we have experienced savings of \$32,000 from our projected budget.

There had been a budget of \$75,000 for the MHA Grant Program in support of Power Skating, however there was only \$45,518 spent which made up the majority of the savings in that area.

The remainder of the savings were spread over many of the programs within this area.

There was an increase in the amount of volunteers taking the on-line education courses of which Hockey Saskatchewan covers the cost of; there was a new U13 Male Program ran very successfully in March and April; the Defensemen only PD camps saw a big increase in attendees; there was an increase if Officials coaching or supervision.

Excellence

The Excellence Section is Schedule 7, Page 12.

Overall, in this area we experienced savings of approximately \$51,552.

Considering the size and scope of the Excellence (Sask First) Programming budget, there were saving across all aspects of the program. We tend to budget conservatively as we do not know from year to year where volunteers within the programs will be travelling from along with items such as the cost of ice in the facilities rented to host the programs.

Hockey Canada Insurance/Membership/Other

The amount of membership fees paid to Hockey Canada saw an increase over the previous season due to an increase in the fees charged by Hockey Canada which was offset by the \$2.00 increase in the per participant fee.

For the year ended April 30, 2026

(with comparative figures for the year ended April 30, 2025)

1. Nature of operations

Hockey Saskatchewan, ("the Organization") is a provincial sports governing body that administers the operations of hockey in Saskatchewan. Its primary objectives are to foster and promote hockey and to promote, supervise and administer all competitions for hockey in Saskatchewan. The Organization was continued under *The Non-Profit Corporations Act, 2022* of Saskatchewan. The Organization is exempt from paying income tax under paragraph 149(1)(l) of *The Income Tax Act*.

2. Significant accounting policies

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations. The financial statements required management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the period. These estimates are reviewed periodically, and, as adjustments become necessary, they are reported in earnings in the period in which they become known. The financial statements reflect the following accounting policies:

Financial assets and financial liabilities are recorded on the statement of financial position when the Organization becomes party to the contractual provisions of the financial instrument. All financial instruments are required to be recognized at fair value upon initial recognition, except for certain related party transactions. Measurement in subsequent periods of equity instruments is at fair value. All other financial instruments are subsequently measured at amortized cost adjusted by transaction costs, which are amortized over the expected life of the instrument.

Fair value is the amount at which a financial instrument could be exchanged at arm's length between willing, unrelated parties in an open market. Changes in fair value of financial instruments measured at fair value are recognized in the excess of revenues over expenses. When there is an indication of impairment the carrying amount of financial assets measured at amortized cost may be reduced. Such impairments can be subsequently reversed if the value improves.

When there is an indication of impairment and such impairment is determined to have occurred, the carrying amount of financial assets measured at amortized cost is reduced to the greater of the discounted cash flows expected or the proceeds that could be realized from sale of the financial asset. Such impairments can be subsequently reversed if the value improves.

The Organization's financial instruments consist of cash, accounts receivable, investments, accounts payable and accrued liabilities. The fair value of these instruments approximates the recorded amounts.

Inventory

Inventory is valued at the lower of cost and net realizable value.

HOCKEY SASKATCHEWAN NOTES TO THE FINANCIAL STATEMENTS

Tangible capital assets

Tangible capital assets are recorded at cost less accumulated amortization. Amortization is provided over the estimated useful life of these assets using the following rates and methods:

Vehicles	20% straight line
Software	100% straight line
computer hardware	33% straight line

Revenue recognition

The Organization follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year the related expenses are incurred. Unrestricted contributions and grants are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Registration fees and insurance are recognized over the hockey season, which begins and ends within the Organization's fiscal year. Fees related to camps, clinics, evaluations, marketing, officiating and other hockey activities are recognized when the event is held. Investment income is recognized as it is earned. Sales of merchandise are recognized when the items are delivered to the customer. Other revenues are recognized when the goods or services are provided.

The Saskatchewan Development Model Scholarship Fund will be used to fund up to twenty four \$1,000 scholarships to eligible members each year.

The Hockey Saskatchewan Scholarship Fund provides scholarships to registered eligible members on an annual basis. The balance in this fund may only be reduced with the approval of at least two thirds of the membership at the annual general meeting.

7. Risk management

The Organization has a risk management framework to monitor, evaluate and manage the principal risks assumed with financial instruments. The significant financial risks to which the Organization is exposed are:

Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Organization is exposed to credit risk on accounts receivable and investments. Accounts receivable are monitored regularly and any amounts deemed uncollectible are expensed. Credit risk of investments is managed through an investment policy and regular monitoring of the accounts. The Organization has incurred insignificant bad debt expense during the past two years.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Organization's exposure to liquidity risk is dependent on the receipt of funds from its operations. Funds from these sources are primarily used to finance working capital and capital expenditure requirements, and are considered adequate to meet the Organization's financial obligations.

Market risk

Market risk is the risk of loss that results from fluctuations in equity prices, interest rates and exchange rates. The Organization is exposed to market risk on its investments. This risk is managed through regular monitoring and through its investment policy.

8. Saskatchewan Hockey Hall of Fame

The Organization controls the Saskatchewan Hockey Hall of Fame (the "Hall") as its sole member. The Organization elects the Hall's board of directors and oversees all administrative services. The Hall is incorporated under *The Non Profit Corporations Act, 2022* of Saskatchewan and is exempt from income tax.

The Organization has not consolidated the Hall into the financial statements. The financial statements for the Hall as of January 31, 2026 and 2025 are as follows:
