The current Board of Directors as well as much of the membership supports a potential Bylaw change that would see the Board structure amended to become a 9-member Board with all members being of the same stature opposed to the current 7 Officers & 16 Directors (23 Board Members).

This change will be presented to the membership for consideration at the 2022 AGM in June.

Our current Bylaws currently allow any interested person to express interest and submit a nomination package endorsed by any Minor Hockey Association within their zone of residence. The complete nomination package must be received by the Hockey Saskatchewan General Manager no later than February 28th.

Hockey Saskatchewan will conduct the normal elections as per Bylaws even though the Board structure very well may change in June. If the Bylaw amendment is passed at the June AGM the Board members at that time will be empowered to determine the formation of the new Board of nine individuals.

Hockey Saskatchewan ZONE DIRECTOR'S ROLE – OVERVIEW

*** Please read & understand each of the following statements ***

□ **Important dates –** Nominations are due to the General Manager at Hockey Saskatchewan by Feb 28th. The names and nomination submission of the valid nominees will be provided to the eligible members of their zone at their respective Spring zone meetings for a vote.

□ **Zone meetings/election** – There are roughly 10 virtual zone meetings each hockey season. There is the potential of an election for a zone director at each spring zone meeting as the twoyear terms for directors begin on alternate years. If there are no nominees and a vacancy occurs, the existing Board of Directors may recruit and appoint a zone director at any time.

□ **Board/Committee Meetings:** There are typically four (4) Board meetings and additional Committee meetings during the year. The number of Committee meetings and timing are dependent on the requirements of the season.

□ **Fiduciary Responsibility:** Represent the best interest of the province, not individuals or any one specific Minor Association.

□ **Conflict of Interest:** All directors of the Hockey Saskatchewan are expected to conduct themselves in a manner that will prevent both a conflict of interest and an **appearance of a conflict of interest**. Directors should not place themselves in a position of obligation to any person who could gain any special treatment from Hockey Saskatchewan. Directors should not have a monetary or other interest that could conflict or appear to conflict in any manner with the discharge of their duties and responsibilities as a director of Hockey Saskatchewan. (Copies of the Regulation and Bylaws, Policies, and the Board of Directors Practices and Procedures Manual are available from Hockey Saskatchewan.)

□ **Criminal Record Check and Vulnerable Sector Check –** These **must** be completed and accompany this application form (within the last 6 months). CRC's need to be renewed every 3 years if elected.

□ **Hockey Saskatchewan Code of Conduct Agreement** – Each member of the Board of Directors must read, understand and sign in acknowledgement - the general code of conduct policy of Hockey Saskatchewan.



HOCKEY SASKATCHEWAN ZONE DIRECTOR'S ROLE DESCRIPTION

Successful candidates will receive an orientation to the Hockey Saskatchewan Board of Directors at the appropriate time. Following is some descriptors of what the role typically includes

The Board of Directors of the Hockey Saskatchewan currently consists of:

Seven (7) Officers Sixteen (16) Zone Directors (Eligible Zone Directors are elected to the Officers positions at the appropriate times)

Term: Directors are elected for a 2-year term or appointed until the next election cycle.

<u>Meetings:</u> 4 Board meetings are held per year – close to Nov. long weekend, early in Jan., middle of April, later part of June (Weekends - start Saturday morning, end by Sunday at noon.)

<u>Committees:</u> Usually appointed to 1 or 2 committees and/or subcommittees which meet at least once a year and/or have conference calls as required. In the case of the Registration Committee there are significantly more (+10) conference calls once a week starting in August.

<u>Sask First</u> – Directors should plan to attend one or more of the program's events. Male U15, Male U18, Female U16, Female U18

<u>Provincials</u> – The general manager develops the provincial draws and gains Board approval at the January Board meeting. Directors **may** be involved with coordinating and administering the Hockey Saskatchewan provincials and **must** be available to support presentations at the conclusions of all Provincial draws.



Hockey Saskatchewan ZONE DIRECTORS SHALL:

- Attend all Board of Directors Meetings and scheduled Zone meetings.

- Contribute towards the liaison of hockey in the zone they represent and to bring forth feedback and recommendations to the Board of Directors. This representation does NOT only include your local community or minor association rather the entire zone.

- Contribute to the ongoing growth and betterment of Hockey Saskatchewan and promote its Vision and Mission through initiatives and activities within the association.

- Review, amend and approve recommendations from the Officers in all areas of policy formation, governance and program development for the association.

- Support the operations of the association in the following ways;

- Liaise with leagues that are within the Zone they reside
- Shall support all Hockey Saskatchewan Provincial Playoff Coordination
- Shall support all Hockey Saskatchewan Sask First Programing efforts
- Promote all aspects of the Hockey Saskatchewan Vision, Mission, goal areas
- Promote and support all programs & services.

The Hockey Saskatchewan Board Orientation details the divisions and operations of the association. Board members represent Hockey Saskatchewan **at all times**, however when doing so in an **official capacity** they can be reimbursed for their expenses in accordance with the association's policies.

The Directors collectively represent the membership of Hockey Saskatchewan and the interests of its associated entities and are charged with the fiduciary responsibilities of exercising visionary leadership, establishing values and goals, setting policies and procedures, supporting the employees and volunteers of the association and respecting them as partners in advancing the mission of Hockey Saskatchewan.
